A meeting of the Essex County Board of Taxation was held on Thursday, April 11, 2013 at 9:15 a.m. at its office, 50 South Clinton Street, Suite 5200, East Orange, NJ.

1. ROLL CALL

Upon roll call, the following members were present: President Willis, Commissioners Johnson, Linares, Matarazzo, O'Brien and Administrator Durkin. Commissioner DeFuria was absent.

2. Approval of March 2013 Minutes

Motion made by Commissioner O'Brien, seconded by Commissioner Matarazzo to approve the minutes of March 2013 meeting. All were in favor, motion carried.

3. Status of Irvington and Orange Revaluation

Irvington

Sylvia Forbes, Tax Assessor of Irvington updated the Board regarding the progress of the revaluation. Discussion followed regarding the many corrections the State is requesting for the township tax maps.

Commissioner Johnson recused himself.

Orange

Matt Rinaldi, Tax Assessor of Orange updated the Board regarding the progress of the revaluation. Tyler Technologies contract was received by the State on March 25, 2013. Township waiting for a response from the State regarding the tax maps.

Commissioner Johnson returned

4. Adopt 100% Resolution

Commissioner O'Brien, seconded by Commissioner Matarazzo to approve the 100% Resolution, made a motion. All were in favor and the motion carried. (Resolution read into the minutes)

5. Approval of East Orange Overrides

A motion to approve the 2013 amended Preliminary Equalization Table and the 2013 Final Equalization Table subject to review and approval from the State and Auditor was made by Commissioner Johnson. Commissioner O'Brien seconded the motion. All were in favor and the motion carried.

7. Motion to approve Tax Court Pending, Assessors Appeals, Affirmances, Stipulations and Withdrawals.

Judgments were not completed at this time. This motion was withdrawn.

8. Status of Deeds

Administrator Durkin stated that the number of transactions have increased by 600 since this time last year.

9. Status of Appeals

Administrator Durkin stated the total of appeals in the system as of today is 5,681. There are four towns that have the deadline of May 1st. East Orange, Glen Ridge, Maplewood and Newark.

10. Procedures and Scheduling of Appeals

Administrator Durkin stated that when final count of appeals is completed a decision would be made if extension would be requested. A discussion followed regarding scheduling.

11. New Business

Discussion regarding new judgment codes, abatements and exceptions.

12. Adjournment

There being no further business the meeting was adjourned at 9:40 am on a motion made by Commissioner O'Brien and was seconded by Commissioner Johnson. All were in favor and motion carried.
