A meeting of the Essex County Board of Taxation was held on Monday, December 14, 2015 at 9:06 a.m. at its office, 50 South Clinton Street, Suite 5200, East Orange, NJ.

### 1. ROLL CALL

Upon roll call, the following members were present: President O'Brien, Commissioners DeFuria, Grodman, Stewart and Administrator Durkin. Commissioner Matrazzo, Jr. arrived at 9:08 and Commissioner Johnson arrived at 9:20. Commissioner Linares was not present.

### 2. Approval of November 2015 minutes

President O'Brien requested to approve November 2015 minutes later in the meeting on the arrival of Commissioner Matarazzo and Johnson. Commissioner Matarazzo made the motion to approve the November 2015 minutes. Commissioner Stewart seconded the motion. All were in favor and the motion was carried.

Commissioner Matarazzo arrived at 9:08 a.m.

## 3. Update Caldwell and Essex Fells Revaluations

George Librizzi, Caldwell Tax Assessor and Kevin Espositio, Essex Fells Tax Assessor both stated that the processes of the revaluations are moving forward. Discussion followed regarding tax maps and contracts.

# 4. Chapter 101 Compliance Plans – Motion to approve the following towns: Bloomfield, Cedar Grove and West Caldwell

Administrator Durkin stated that she met on December 10th and discussed with both Assessors regarding their Chapter 101 Compliance Plans.

**Township of Bloomfield** - Joe Pisauro, Tax Assessor stated eight neighborhoods had to be adjusted. Commissioner Stewart made the motion to approve the Township of Bloomfield Chapter 101 Compliance plan. Commissioner DeFuria was second to move the motion. All were in favor.

<u>Township of Cedar Grove</u> – Richard Hamilton, Tax Assessor stated that three neighborhoods had to be adjusted. Commissioner Grodman made the motion to approve the Township of Cedar Grove's Chapter 101 Compliance plan. Commissioner Matarazzo was second to move the motion. All were in favor.

**Township of West Caldwell** – Richard Hamilton, Tax Assessor withdrew the application for the Chapter 101 Compliance plan.

### 5. Update on Deeds

Kenya Kourkoulis, Administrative Assistant stated that as of November  $30^{th}$  6,220 deeds have been processed. That is an increase of 545 deeds from this time last year.

### 6. Update of Nutley Assessor

Administrator Durkin stated that she is aware that the position was offered to someone but no formal notification from the Township as of yet.

# 7. Update of Revaluations for Belleville, Maplewood, Millburn, Montclair, Nutley and South Orange

**<u>Belleville</u>** – Kevin Esposito, Tax Assessor stated that an engineering firm is reviewing and revising tax maps, RFP to be prepared.

<u>Maplewood and South Orange</u> - Edward Galante, Township of Maplewood Tax Assessor, Roger Desiderio, Esq. Township of Maplewood Tax Appeal Attorney and Ellen Malgieri, Township of South Orange Tax Assessor were present. Discussion was had regarding timeframe for the application for Reassessment and criteria.

**Millburn** – Administrator Durkin stated that tax maps would be the issue with Millburn as well.

<u>Montclair</u> — George Librizzi, Tax Assessor stated that funds are in the budget for the revaluation, tax maps sent to State with changes.
