1. ROLL CALL

In attendance via Zoom Conference were President O'Brien, Commissioners DeFuria, Grodman, Johnson, Matarazzo and Administrator Durkin.

2. MOTION TO APPROVE JUDGMENTS RENDERED IN JUNE 2020 AND ANY AMENDED JUDGMENTS

A motion to approve Tax Appeal Judgments, Stipulations of Settlement, TCP and Withdrawals with the exception of the Newark Settlement on Block 151, Lot 122.01, 3 Gateway Center Properties was made by Commissioner Grodman, Seconded by Commissioner Matarazzo, all in favor, with the exception of Commissioner Johnson who abstained, motion approved.

It is also noted that Commissioner Johnson abstained from voting on all matters stated above related to the Towns of Bloomfield, East Orange, Newark, Orange and West Orange.

A discussion followed on the Newark matter, and it was decided to request from the Assessor, Aaron Wilson, and the taxpayer 3 Gateway Center properties to supply supporting evidence there will be a phone conference ASAP to either approve or deny the Settlement Stipulation.
